# FINANCE ADVISORY BOARD REGULAR MEETING MINUTES (DRAFT) VIRTUAL/IN PERSON MEETING TUESDAY JULY 25, 2023 5:30 PM

#### 1. CALL TO ORDER

The meeting was called to order by Chairman Anthony Savastano at 5:35 p.m.

#### 2. ROLL CALL

Present in person on behalf of the Financial Advisory Board were John Ballew, Doug Lyon, Anthony Savastano, Jessica Wheeler, and Tom Barney. Board Members present virtually included Jasper Welch, and Roger Zalneraitis. Staff in attendance included Allison Baker, Public Works Director; Devin King, Multimodal Manager; Scott McClain, Assistant Parks Director; Acting Chief Financial Officer and Staff Liaison Devon Schmidt; and virtually, Sarah Hill, Transportation Director.

#### 3. APPROVAL OF MINUTES

3.1. Board Member Lyon motioned to approve the draft June 14, 2023 Financial Advisory Board regular meeting minutes. Board Member Ballew seconded the motion. All were in favor, motion passed unanimously.

The motion passed: 7 in favor; 0 opposed; 0 abstained; 1 absent

3.2. Board Member Lyon motioned to approve the draft June 21, 2023 Financial Advisory Board regular meeting minutes. Board Member Ballew seconded the motion. All were in favor, motion passed unanimously.

The motion passed: 7 in favor; 0 opposed; 0 abstained; 1 absent

3.3. Board Member Lyon motioned to approve the draft July 10, 2023 Financial Advisory Board study session minutes. Board Member Ballew seconded the motion. It was noted that the Board was only able to address half the agenda. All were in favor, motion passed unanimously.

The motion passed: 7 in favor; 0 opposed; 0 abstained; 1 absent

The Board asked to have it noted that at the June 14, 2023 FAB meeting, the Board discussed how the Board is going to relate information to City Council without a City Council liaison, and that this topic be included on a future agenda.

#### 4. PUBLIC PARTICIPATION

Stephanie Owens-Edwards, Southwest Pickleball Association President, said that pickleball is the fastest growing sport with an average age of players is 38. The community has rallied for pickleball courts for a very long time. When considering the additional cost, remember that a pickleball outdoor complex generates income by bringing people in for tournaments. Ms. Owens-Edwards added that by postponing the project, construction costs will only get higher.

Non-city resident Bruce Moss commented that as a City of Durango employee at the Durango Community Recreation Center and work closely with the pickleball groups and it continues to grow exponentially in popularity and gave national statistics on this growth. The City needs these courts.

Durango resident Seth Furtney commented that there are a whole host of plans within the Parks and Recreation Department that have been adopted by the City that are not being utilized and would like to see this Board benefit from them.

Board Chair Savastano let Mr. Furtney know that the Financial Advisory Board library is inclusive of all those documents.

# 5. REPORTS: Continuation of July 10, 2023, Study Session of 2024 Capital Improvement Project (CIP) Proposal - Staff Presentations

- 5.1. 2024 CIP Plan for Sewer from July 10, 2023 Study Session was *tabled* until the continuation of the Study Session.
- 5.2. The Board review the mid-Year Capital Improvement Projects Appropriations for City Council:
  - 5.2.1. For the 2005 Tax Fund, the Board was informed that staff is still working on an easement for alignment of the SMART 160 Trail, and not ready for the construction this year. In addition, the Schneider Pickleball Courts project bid came in over 1 million than what was budgeted in 2023, and therefore would like to transfer \$1 million from the SMART 160 project to the Schneider Park Pickleball project The Board discussed the history of this project, the high cost compared to other communities, the benefits of it being in Schneider Park, and that a portion of the project is for park improvements, so therefore call the project Pickleball Courts and Schneider Park Improvements.

Board Member Lyon motioned to approve the requested adjustments to the 2005 tax fund for the 2023 Budget, reduction of \$1 million in the SMART 160 Trail budget, and increase of \$1 million to the Pickleball and Schneider Park improvement project to \$1,900,000. Board Member Barney seconded the motion. All were in favor, motion passed unanimously.

The motion passed: 7 in favor; 0 opposed; 0 abstained; 1 absent

5.2.2. The Board discussed the mid-year adjustments listed for the 2015 Sales Tax projects, which included Community Forestry Management Plan, with bids exceeding the allocated \$75,000 by \$65,000; Mid-year adjustment for Chapman Ski Hill Improvements to include the replacement of the existing lifts, lighting, electrical engineering needed and earthwork, all into 1 project instead of 3; and the Multimodal Downtown's Next Step design increase of \$120,000. Staff said the ART Santa Rita Park to CR 210 asphalt replacement project will not start in 2023 and request a reduction of this project to cover mid-year adjustments. The Boards discussed future lift costs and parking issues at Chapman Hill.

Board Member Lyon motioned to increase the Community Forestry Management Plan by an additional \$65,000, for a total of \$140,000. Board Member Barney seconded the motion. All were in favor, motion passed unanimously.

The motion passed: 7 in favor; 0 opposed; 0 abstained; 1 absent

Board Member Barney motioned to increase Chapman Ski Hill project by \$729,695 for a total of 3,029,695, to now include replacement of lighting and big tow rope. Board Member Ballew seconded the motion. Board Members in favor were Lyon, Ballew, Barney, Zalneraitis, Welch, and Savastano. Board Member Wheller abstained. Motion passed.

The motion passed: 6 in favor; 0 opposed; 1 abstained; 1 absent

Board Member Wheeler motioned for a reduction of \$655,000 from the ART, Santa Rita Park to CR 210 asphalt replacement project. Board Member Lyon seconded the motion. All were in favor, motion passed unanimously.

The motion passed: 7 in favor; 0 opposed; 0 abstained; 1 absent

Board Member Barney motioned to increase the Downtown's Next Step project. Board Member Ballew seconded the motion. Board Members in favor were Lyon, Ballew, Barney, Welch, Wheller and Savastano. Board Member Zalneraitis abstained. Motion passed.

The motion passed: 6 in favor; 0 opposed; 1 abstained; 1 absent

5.2.3. The Board discussed the mid-year adjustments listed for the 2019 Street Sales Tax projects, which included: A decrease in the 8<sup>th</sup> Ave/College St. Intersection and Roads, pavement only, (\$460,000); An increase of Alley Reconstruction project by \$39,448; An increase of the N. College Reconstruction by \$18,430; and An increase in Roosa Avenue Storm Drain Emergency Replacement, \$10,000. New projects needing funding include Crack-sealing Material, \$50,000; 7<sup>th</sup> St. at D&SNGRR Crossing Upgrade, \$70,000; Design all unpaved Alleys, \$170,000; CDOT Paving at 14<sup>th</sup> St. W, \$30,000; and Traffic Signals Electric Repairs/Grounding, \$50,000. It was determined that there were plenty of funds in the 2019 Fund Balance to cover these mid-year 2023 adjustments.

Board Member Wheeler motioned to approve the 2019 Streets Sales Tax Capital projects mid-year adjustments. Board Member Zalneraitis seconded the motion. All were in favor, motion passed unanimously.

The motion passed: 7 in favor; 0 opposed; 0 abstained; 1 absent

5.2.4. The Board discussed the mid-year adjustments listed for the 2019 Street Sales Tax projects, which included: SRWRF Waterline Replacement, \$65,000; SCADA Cybersecurity Improvements, \$25,000; SRWRF Primary Clarifier Liner Replacement, \$120,000; and SRWRF Operator Workstation Remodel, \$35,000. It was determined that there was plenty of funds in the Sewer Enterprise Fund Balance to cover these mid-year 2023 adjustments.

Board Member Lyon motioned to approve the 2023 mid-year adjustments for the Sewer Enterprise Fund. Board Member Zalneraitis seconded the motion. All were in favor, motion passed unanimously.

The motion passed: 7 in favor; 0 opposed; 0 abstained; 1 absent

5.2.5. The Board discussed the mid-year adjustments listed for the Water Construction Fund Budget, which included: Wildcat Tank Improvements, \$93,200; and CMWTP Filter Effluent to Waste System, \$60,000

Board Member Zalneraitis motioned to approve the 2023 mid-year adjustments for the Water Construction Fund. Board Member Wheeler seconded the motion. All were in favor, motion passed unanimously.

The motion passed: 7 in favor; 0 opposed; 0 abstained; 1 absent

5.3. Cross-Functional Team Update on Focus Group was *tabled* until the continuation of the Study Session.

# **Overview / Background Information**

Chapman Hill Flooring is concrete with a softer rubberized flooring placed on top to allow people to walk on it with skates. In 2020, when the initial flooring was replaced the glue failed or was installed incorrectly. The flooring is bubbling and unsafe. The claim is with the City legal department for damages.

**Ballot Language:** Funds to be used for "the costs of the construction, operations or maintenance of recreations facilities, parks, trails, pedestrian and bicycle improvements, maintenance facilities used by the Parks and Recreation department, and the Urban Forest; with all expenditures based on the recommendations of a citizens advisory board to the city council..."

#### **Purpose**

Staff is recommending a re-appropriation in 2023 to the 2015 dedicated sales tax for POST to make an emergency fix of the flooring so that it is usable when the rink opens for the ice season.

- The issue is being evaluated by the City's legal department to seek damages either from the original contractor who installed or the glue company.

# **Overview / Background Information**

As part of the annual budget process, staff make recommendations for capital improvement projects midway through the current year. These projects are budgeted to commence the following year. The city does not approve funding for multi-year projects. All projects require annual funding approval.

This proposal is for the 2005 Dedicated Sales Tax for Parks, Open Space and Trails. This year, there are projects with timing consideration that are being adjusted between the 2<sup>nd</sup> half of 2023 and 2024.

**Ballot Language:** Funds to be used for "fifty percent used to finance the preservation, acquisition, and maintenance of natural lands, including but not limited to land to preserve water quality in rivers and streams, wildlife habitat, land for hiking and biking, and the creation and maintenance of parks and trails and fifty percent used to finance capital improvements including, but not limited, a new library, road, sidewalk and associated improvements to enhance driver pedestrian and bicycle safety..."

#### **Purpose**

Staff is proposing a budget amendment to the 2005 Parks and Open Space and Trails ¼ Cent Dedicated Sales Tax.

#### **Impact Analysis**

- Bids for the Pickleball Courts and Schneider Park improvements came in higher than expected at \$1,900,000. The extra expense is being mitigated by moving the funding timeline forward to prevent any further cost increases.
  - Most of the cost increases are due to grading, drainage, general park improvements to Schneider Park, and installation of lighting adjacent to the Animas River Trail along with the installation of the Pickleball courts.
- The SMART 160 Trail project is being delayed with easement discussions for portion of trail across private property and are being moved to 2024 based on the easement negotiation and consideration for balancing the fund and retaining a positive fund balance.

#### **Strategic Plan & Goal Alignment Analysis:**

- Parks support the Enhanced Livability and Sense of Place Strategic Plan goal.
  - By making these amendments we will be able to better distribute funds in accordance with timing needs of the different projects.
- Durango has sought dedicated pickleball courts for several years with several locations considered. We now have a contractor on schedule to get them installed.
- Schneider Park Restrooms will be installed after the general improvements made with the implementation of the Pickleball courts.
- SMART 160 has been delayed due to easement negotiations with a private landowner and construction of a road on private land.
- Land Acquisition is ongoing, but contract negotiations are not likely to need funding until 2024.

# **Strengths / Weaknesses / Mitigating factors**

- + We will maintain a growing fund balance in preparation for large projects in 2024.
- + Pickleball courts will begin construction in 2023.
- + Schneider Park will have general improvements made and addition of Animas River Trail lighting through Schneider Park.
- + We will work within timing constraints of 3<sup>rd</sup> parties to the City of Durango.

#### Impact Analysis

- The Durango Mesa Park Demonstration Trails are currently being constructed and the Bike Park is in design phase, with construction scheduled for 2024. Design work for infrastructure is currently in progress and will continue into 2024.
- The replacement of the Chapman Ski Hill little tow rope, the big tow rope, and the lighting are being combined into one project for better ordering and cost efficiencies.
- The road improvements at Lake Nighthorse are being managed by the Federal Lands
  Highway Division. Design and engineering are in progress, with project bidding
  scheduled for 2025, and construction likely in 2026. The Lake Nighthorse Entry and
  Decontamination station is currently out to bid with construction anticipated to start
  this fall and completion in spring of 2024.
- The replacement of three existing sections of Animas River Trail is currently being designed with plan to bid for construction over the next couple of years.
- The College & 8<sup>th</sup> Safety Project did not receive construction bid responses in 2023. Staff is requesting that the funds be re-appropriated to 2024 so the request for proposals can be modified and re-bid for a summer 2024 construction.
- Phase 1 and Phase 2 of the ADA Transition Plan Design and Construction were combined into one project based on additional grant revenue that was awarded in 2023. The project will include full design and construction and will continue into 2024.
- Design of the Camino Crossing Project was paused for negotiations between the City and DFPD concerning future site implications of the River City Hall campus. Now that there has been resolution, design will resume, and funds are requested to be reappropriated into 2024.
- The MidTown Safety and Connectivity Project is currently under design. Due to the complexity of the project and the necessary public engagement, design will continue into 2024.
- 32<sup>nd</sup> Street Traffic Calming Project has reached 95% design. The remaining funds are requested to be re-appropriated to 2024 to fund the bid package for construction.
- The Downtown's Next Step Project Phase 1 design is anticipated to continue into 2024.
   It is included in the midyear adjustment request to fund the up-front site analysis costs of the entire corridor. The entire design cost of all 3 phases is not anticipated to be impacted.

- The fund will have large expenditures and encumbrances in 2023, due to construction contracting requirements to secure early 2024 construction and will continue to see projects in 2024 but will grow the fund balance in 2024 for higher reserves.
- Several of the projects are being budgeted in 2023 but will not have full expenditures of those funds in 2024. We are encumbering the funds per contract requirements for the projects so there will be funds available as certain milestones of projects are met.

#### **Impact Analysis**

- CR 250/ 251 project is being contracted in 2023 but will have multiple years of expenditures. La Plata County is committing 50% of the construction cost to their portion of \$8.8 million, based upon actual bid costs, which is an increase over their \$3.5 million commitment in 2023 from a \$6.6 million estimated construction cost.
- Several of the projects continue to be reappropriated due to lack of bids on projects that were reliant on MultiModal project completion when some MultiModal projects did not receive bids.
- Streets/Engineering is working to create joint projects with MultiModal to attempt to appeal to more bidders by creating larger projects.
- The city is competing for contractors with nearby large CDOT projects. This is one of several factors contributing to the price increase of the projects that do receive bids.
- The North College redesign will improve traffic calming, drainage, utilities, and multimodal accessibility on the road.

- In 2024, we have not had adequate design management staff to ensure that consultants meet design schedules.

This will increase the biological breakdown in the anaerobic digesters, reducing or offsetting energy consumption through methane gas recovery.
